# Discussion with Rev. Candea — Dawn Lessiack, board member

### <u>What from your viewpoint were the issues at the</u> <u>time of Martin and Katie Luther?</u>

Major issues were poverty, decreased status of women, illiteracy, disease and illness; and indulgence, corruption and abuse of the church. There was a definite divide between the wealthy and poor with government and church using that division as a way to control people. Everyone was expected to attend church but only the priests could read and lead the Latin worship. Most people could not read so they were not informed or able to read the Bible themselves. The church came up with the idea of selling indulgences to pay for the operations of the church and building the cathedral in Rome.

### How did the Luthers solve these issues:

Martin wrote the 905 Thesis as a *discussion* tool and did not want to leave the church. Yet both left and hid for their safety. They then married and were hosts to many people and helped the poor and orphaned. Martin translated the Bible into German. He wrote many works to continue the theological discussion of the church. He educated those who would become the leaders of the changing times and the Reformation.

Their primary actions were to be witnesses of caring and staying. From the beginning Jesus' ministry, Christians are the ones who show compassion and who care for the poor, sick and dying. People ask, "Why are you doing this?" Christians respond, "Let me tell you about Jesus."

### What are the major issues we now face?

Major issues now are apathy, decreased morals, division of church and society, intolerance of divergent views, and still a decreased status of women. Charismatic churches seem to be offering something not found in our mainline denominations. We have lost our identity as an evangelical church. We do not communicate well about who we are and what we do. We often do not reach out because of fear being rejected or labeled as a zealot. We stay focused inward as a protection mechanism which makes the issues tougher. We have lost the priority of God first and family second. Members do not attend their local church Sunday morning, which appears that they are not active or contributing to the congregation. Parents place other social activities and sports first before church attendance. Grandparents also are attending these activities, visiting family or scheduling other events. Perhaps we are stuck in the old thinking of "what does attendance mean?" People still claim to be spiritual but do not affiliate with a denomination or contribute to a local church. We have buildings that are difficult to maintain and pews that are not full.

We are part of a Reformation. The Reformation changed not only the church and religion, but culture, politics, education and society, as well. Who and what are we going to trust? What is Christ calling us to do as the ELCA, our synod, our congregations, and as an individual believer, here and now?

How do we deal with death? Perhaps it is not closure, but more like reconciliation. We learn to cope with and accept

that our daily life has changed and that is okay. Sometimes, we carry regret and guilt as a way to not forget our loved one.

Death is not only people, but pets; and, divorce, moving, kids growing up, lifestyle changes and retirement. We may be relieved, but feel guilt, anger, fear and a sense of being lost. We have a missing piece of identity. Our routines changed. A partner is gone. We have lost our dreams and plans.

We often have to reconcile our own mortality. We may not be afraid of death, but rather how we will get there. Will we suffer in pain? Be alone? Or have no one to care for us? Will we be in a hospital, nurs-

There are five stages of grief: denial and isolation, anger, bargaining, depression, and acceptance. But we may not experience them in order or within a certain time frame. Emotions will surface at unexpected times or even years later. We may need the help of a bereavement support group. A couple ladies said they attended two sessions and could perhaps benefit from a third.

While people try to say kind things, such as, "It is God's will", "God needed another angel", or "God takes only the best", those comments are not helpful. Others also may question how we spent our time before and after a death by asking, "Why were we with them all the time? Why didn't we ask some-

one else to do it? "But we do not have to be embarrassed or apologize for our actions.

# End of life planning is a gift to loved ones.

Our social and spiritual life changes in many ways. We are no longer a couple so we may feel uncomfortable with our friends. We may not sit with the same people or in the same pew. We may not feel like attending church or other organizations.

End of life planning is a gift to loved ones. It may seem morbid and your children may not want to talk about it. Or, perhaps, your children want to discuss plans and you do not. This can be a time to accept that life changes. You may want to share your requests and finances, household goods, etc., so that it will be easier when your death does occur. You want to see others enjoy your life's labors and items they have admired. It may feel like a burden has been lifted.

Planning and written directives can save many disagreements, hurt feelings and misunderstandings when our loved ones are under extreme stress and grief. They may not see it now, but they will be grateful when making funeral, financial and legal arrangements.

### Engage people to end poverty — Anna Prockish, board member

Many convention attendees asked for more information on the *Circles of the USA* presented by a speaker from *Circles of McPherson County*.

*Circles USA* is the result of more than 20 years of research and the development of leadership tools for committees by *Move the Mountain Leadership Center.* The Circles model was developed after the organization discovered that social agencies could reach only a small portion of the population living in poverty to present them with real long-term solutions.

# BUILDING COMMUNITY TO END POVERTY ONE FAMILY AT A TIME

Circles addresses poverty by increasing the capacity of communities. Its approach combines the best practices of community organizing, case management, grassroots leadership, S.M.A.R.T., goal setting, financial literacy, mentoring, peer-to-peer counseling and learning, and child/youth development.

The underlying foundation of Circles is to engage people and organizations in the community to



thrive and end poverty. Its manifest states, "We believe strongly that responsibility for both poverty and prosperity rests not only in the hands of individuals, but also with societies, institutions and communities."

In order to get out of poverty, people need both education and social capital (people who can offer information, contact, and support). Circles connects people in relationships across income lines and helps develop clear goals for education and stable income. Circles also focuses on supporting families to help themselves completely out of poverty.

Circles of McPherson County works with McPherson County families living in poverty and are ready to make the changes in their lives to become more stable and self-sufficient.

Kansas locations are: Derby, Great Bend, Greensburg, Hutchinson, McPherson, Newton, Marion, Olathe, Pratt, Salina, Topeka, Wichita and Winfield. Missouri locations are Joplin and Springfield.
